African Palm & Murder in Honduras: In memory of CESAR VIRGILIO PINOT

REVISITING MACONDO: Transnational Fruit Corporation's "security" forces assassinate community activist in Honduras.

Fifty years after the great strike of 1954 that began with banana dock workers and snowballed into a nation-wide action, much has changed and nothing has changed here in Honduras the "Banana Republic".

Control exercised by transnational fruit companies remains firm. Assassinations by company paramilitary forces continue. Impunity is the order of the day.

On Saturday, March 13, 2004, at approximately 3:30pm, CESAR VIRGILIO PINOT, member of the activist cooperative "Martires de Guaymas", and various community members were attacked by "security" forces of Agro Oriental, subsidiary of Tela Railroad Company for the production of palm oil, in the African palm plantations of Toloa Empalme.

Virgilio died as a result of the bullet wounds. JOSÉ NEPTALY LÓPEZ, also a member of the Martires de Guaymas, was wounded ... and subsequently captured!

The root of this brutal act of repression is the organization of various communities -- Kilómetro 32, La Unión, Villafranca and La Tomasa, all belonging to the municipality of Tela, department of Atlántida -- into an

Association of Independent Palm Producers. The Tela Railroad Company,

subsidiary of the US-based transnational Chiquita Brands International Inc.

(itself the direct descendant of the infamous United Fruit Company), has

lost the profits it obtained from the same producers, who previously sold

their product to the multinational.

In response, the company's "security" guards, armed with AK47s, have been

persecuting community leaders. Numerous community leaders active in the

Association have been accused of 'illegal association,' under the reformed

Article 332, known as the 'anti-gang law,' currently being challenged for

its violation of various articles and guarantees of the Constitution. They

have been accused of belonging to a group of car thieves.

Along with Neptaly, various community members also belonging to the Martires

de Guaymas are currently in jail in Tela: OSMAN ALEXANDER BLANCO DUARTE,

WILTON RENE BLANCO DUARTE, ANTONIO BAQUEDANO RAMOS and JOSE MEDARDO REYES

MENDOZA. Police, acting in collaboration with the company paramilitary

forces, have entered five houses by force, holding children and elders at gunpoint.

The transnational fruit company's paramilitary forces act with complete

impunity. In court, the company's "security" forces have not even been

required to testify. Instead, agents of the DGIC - the General Direction of Criminal Investigation - reported that they had spoken with the guards, who were not even identified except for by nicknames, and relayed their responses.

In the case of the assassination of Cesar Virgilio Pinot, authorities accepted the guards' explanation that they murdered Virgilio in self-defense, in response to the latter's attack against them. No one called on the numerous community members who witnessed the attack. Neither has there been any file opened for the case. Nor has the location of Virgilio's body been revealed.

These grave violations are only the latest in a long history of repression and political persecution, accompanied by the complicity of State authorities.
